 - In my research, I apply sociolegal concepts and theories (especially western and Indigenous conceptions of governance, regulation and justice) and diverse legal and social science methods to study environmental, climate, natural resources and energy law and sustainability agendas and regimes— I have recently focused more on climate change, sustainable development and low-carbon transition agendas. I am currently working on multiple articles and two book projects. The articles are at various stages and will be published between 2025 and 2026, but I describe the book projects as the most significant work. One of the books, tentatively titled "Hybrid Regulation: New Governance towards Low-Carbon Economies," is a monograph based on my Ph.D. For this monograph, I have developed ten chapters covering introduction, conceptual review and justification, conceptual and analytical framework, methodology, case studies, comparative generalizations based on the case studies, and conclusion, mostly from my PhD project at UBC and work at Bristol. I am working to add two new forward-looking chapters, based on insights from my PhD case studies and new interviews and focus groups: one creating a realistic model of hybrid regulation that could be applied across different contexts; and the other setting out an ambitious futuristic vision for hybrid regulation going forward. The other book is an edited collection based on the "Re-Imagining Agenda 2063" project, which I initially co-designed and have led at UBC and Law and Society Association before joining the University of Bristol. Under that project, I have recruited academic, policy, industry, and community researchers (currently close to 60) from universities, think tanks, intergovernmental organizations, industries and law firms working on African issues to rethink the idea of "sustainable development" underlying the African Union's policy blueprint for the continent's economic growth by 2063, called "Agenda 2063," within the constraints set by climate change, net-zero targets, biodiversity loss, population growth and other global challenges. I have organized or co-organized four conferences: a panel in the Canadian Law and Society Association Meeting in 2019; a 2021 conference funded and hosted by the Peter A. Allard School of Law and the Liu Institute Network for Africa at UBC; a July 2022 conference funded and hosted by the Law and Society Association at its global meeting at Lisbon; and another conference in September 2022, sponsored by the Liu Institute Network for Africa. I am collaborating with Prof. Rashid Sumaila (University Killam Professor and Canada Research Chair at UBC), Dr. Godwin Dzah (Assistant Professor at the University of Alberta), and Dr. Wanjiku Khamasi (Associate Professor at Dedan Kimathi University of Technology in Kenya) to collect, subject to peer review and publish the strongest papers presented at these conferences by 2026.
 - o I have taught Environmental Law in Bachelor of Laws and Master of Laws, Legal Perspectives on Sustainability and Climate Law in Master of Laws in Environment, Sustainability and Business, and Contemporary Debates in Sustainability in Master of Research in Sustainable Futures. I currently coordinate Legal Perspectives on Sustainability, including guiding and supporting other instructors, and have previously coordinated the other units I have taught.
 - Also, I am supervising or have supervised 1 PhD dissertation on natural health services (using nature for health interventions), 7 master's dissertations on sociolegal aspects of sustainable finance, emissions reduction from aviation, biodiversity conservation, and ocean rights, and 14 undergraduate dissertations and final year research projects on regulation, governance
